TennCare recognizes that providers are being impacted by this breach, both at an individual and organizational level.

HealthEC is notifying individuals that may have been impacted by this breach, but TennCare acknowledges that this communication to providers has been causing additional questions and needed to be clearer.

This includes FAQs regarding the breach and notifications, options for sending letters incorrectly mailed to facilities or organizations, and contact information at both TennCare and HEC for additional questions.


Team Member Celebration is April 6th
